LETTER OF AGREEMENT BETWEEN CHEON INTERNATIONAL NOTAM OF

INCHEON INTERNATIONAL NOTAM OFFICE AND

TOKYO INTERNATIONAL NOTAM OFFICE CONCERNING EXCHANGE OF DOMESTIC NOTAMS

1. GENERAL PURPOSE

This letter of Agreement (hereinafter called "LOA") between Incheon International NOTAM office (hereinafter called "Incheon NOF") and Tokyo International NOTAM office (hereinafter called "Tokyo NOF") is supplementary to the procedures established in 3.3, Chapter 3 of Annex 15 to the Convention on International Civil Aviation concerning exchange of domestic NOTAMs between Incheon NOF and Tokyo NOF.

2. BACKGROUND

On 25 November 2003, Director of Aeronautical Information Services Division of Air Traffic Control Center of Republic of Korea requested Tokyo NOF to send Japan Domestic NOTAMs to Incheon NOF by AFTN in order to enhance the safety of aircraft which are operated from Republic of Korea to Japan.

3. EXCHANGE OF MUTUAL DOMESTIC NOTAMS

Both parties agreed to exchange domestic NOTAMs mutually as follows:

- (1) The distribution of Japanese domestic NOTAMs from Tokyo NOF to Incheon NOF
 - a. Airports whose domestic NOTAMs are to be distributed

Regular airports which airlines of Korea operate to and alternate airports specified by Korean side as shown in Attachment A.

b. The procedures for distribution of domestic NOTAMs

(https://www.aisjapan.go.jp) as well.

- ① Format

 Domestic NOTAMs are distributed in accordance with Attachment B.
- ② Distribution means AFTN
- ③ The address of Incheon NOF RKZZNKXX
- Others
 Domestic NOTAMs will be given through website of Tokyo NOF

- (2) The distribution of Korean domestic NOTAMs from Incheon NOF to Tokyo NOF
 - a. Airports whose domestic NOTAMs are to be distributed

Regular airports which airlines of Japan operate to and alternate airports specified by Japanese side

b. The procedures for distribution of domestic NOTAMs

To be consulted when Japanese side requests

4. EFFECTIVE DATE OF THIS LOA

This LOA is come into effect on 25 June, 2004.

5. REVISION OR CANCELLATION OF THIS LOA

- (1) The party that proposes revision or cancellation of this LOA shall notify the other party by letter, at least sixty(60) days prior to the proposed effective date.
- (2) At the instance of a party's request, both parties shall promptly commence the consultations to revise or cancel this LOA.
- (3) Revision or cancellation of this LOA shall be accomplished by consent of both parties.
